2010 SURVEY QUESTIONS, ISSUES and RESPONSES

(Full survey results will be distributed at the annual meeting.)

Q. What are the overall services Personal Touch (PT) provides?

A. PT will provide a service description at our annual meeting. For future comments regarding PT service, inform a Board member.

Q. Garage and other outdoor light fixtures are becoming worn. Is this an Association issue?

A. Light fixtures are the homeowners' responsibility. Check the "Architectural Guidelines" for any restrictions on your choice for replacement fixtures.

Q. Will there be an association-wide driveway sealer program?

A. This is also the homeowners' responsibility. Watch for or submit information to "For the Birds" to get the word out for future multiple homeowner participation and probable discounts for such projects.

Q. Can a more clear and understandable budget report be provided?

A. The Board worked with PT to revise budget line items to produce a clearer understanding of operating and replacement funds and where our money is allotted and spent. The Board hopes to provide a better budget report format more often than once annually.

Q. Since PT handles our funds, are they bonded for these amounts?

A. Yes, PT is insured and bonded. In addition, Kay Sand is a licensed real estate agent.

Q. For landscaping around my home, I'd like to see general guidelines to follow rather than having to get prior approvals for some personal style.

A. The Architectural Control Committee recommendations to the Board have supported the concept that personal style is not incompatible with maintaining community objectives. The Guidelines document provides the ability to show individual taste while remaining true to compatibility standards set by the Declaration. Not every project requires committee/board review and acceptance; some items have been pre-accepted.

Q. Can we be informed of agenda items for upcoming Board meetings? Can these meetings be held on different evenings?

A. Yes, the Board has begun noting agenda topics for future meetings in the

Board Meeting Minutes, and will consider your request that meetings be scheduled on different weekday evenings.
