THE BOARD "TWEETS"

Some homeowners questioned why this winter's excess snow was placed where it was, so we hope the following two paragraphs help explain the project.

In January the board requested bids to move some snow offsite, since it was piled so high there was nowhere to put any more and visibility was impeded. To move the snow off our property to the dump was not an option due to the prohibitive cost.

Our maintenance company, A-1, submitted the most reasonable, comprehensive bid for relocation of the snow. Agreement was reached to relocate it on our property without worsening possible spring flooding. The board voted to have the project completed for \$3,500.00.

Reminder: The board has an open meeting policy. You are welcome to attend the monthly meetings held at Caribou Coffee in Oakdale at 6:30 p.m. Future board meeting dates are indicated in the previous month's minutes which are sent to your home.

Survey results were delivered to each resident homeowner last month.

Included were answers to some of the most commonly asked questions. If your question or concern wasn't addressed, please follow up with the Board

Remember that Woodbury's winter parking rules remain in effect through April 1. On-street parking is prohibited between 2:00 a.m. and 6:00 a.m.

Homeowners are responsible for repairing any damage to the lawn adjacent to your driveway if you have driven over it during the winter and/or spring and ruined the grass.

Are you planning to plant some greenery around your home in the spring? Or perhaps you're considering a larger tree or shrubbery in the grassy area? Please consult the Architectural Guidelines, Standards and Criteria publication.

"Pre-accepted" plantings within the rock beds do not require submitting an architectural change request. Any changes or alterations with the "contingent" designation require the homeowner to submit a request to the Architectural Control Committee and to wait for written acceptance before making any changes. Please comply with these guidelines.

NEWSLETTER FACTS

Many of you may not know that:

- 1. "For the Birds" is a volunteer project and Personal Touch is not involved in its publication.
