THE BOARD "TWEETS"

In spring and summer months many homeowners begin projects to improve or maintain their homes. Contractors hired to perform these jobs often place advertising signage in the homeowner's yard. Please inform your contractor that such signs are not allowed in our association.

Section 7.6 <u>Signs</u>, in our HG Declaration reads: No signs of any kind shall be displayed to the public view on any Unit except for one sign of not more than five square feet advertising the property for sale.

Past and present Boards have considered that rule severe, as it doesn't allow for occasional garage sales or birthday/anniversary parties.

Historically the Board has not pursued remedial action against homeowners who post signs for such activities as long as the sign is removed immediately following the event, the event lasts 2 days or less and the purpose of the event is not commercial in nature.

BE ON THE ALERT!

Other homeowner associations have

reported theft of copper piping and valuable valves from their irrigation boxes. Heritage Glen's large green irrigation boxes are located in front of 471 Bluebird Lane and on the east side of Woodduck between Bluebird Lane and Blue Heron Lane.

Anyone who is authorized to enter the boxes has the key to get in, so if you notice someone tampering with or otherwise trying to break into the boxes, phone the Woodbury police immediately.

LAWNS and IRRIGATION

If you see sprinkler heads that are broken, fail to retract or are watering anything other than the lawns, please phone Personal Touch or Maintenance Committee Chairman Ray Buczkowski to report the problem so it can be addressed promptly.

On Thursdays, the day A-1 mows the lawns, please don't place your recycling bins on the grass, leave cars parked too close to the lawns, or leave inflatable pools, bicycles and other items on the lawns so that A-1 can do the best possible job.

Remember that our lawn watering schedule has changed. The City of Woodbury agreed to permit both odd and even day irrigation to assist us in our efforts to conserve water.

In mid-May our grassy areas were treated with a granular insecticide to prevent Japanese Beetle grubs from emerging from the soil during the summer. The irrigation system was used to insure the insecticide was adequately integrated into the soil.

A-1 Maintenance has provided tree and shrub pruning services for 27 years. Jon, Rich, Kevin and Leonard all hold undergraduate degrees or are in the process of finishing degrees and attend continuing education classes annually.

It is mandatory for all lawn care staff to attend tree and shrub pruning classes annually. Employees who hold a state license for pesticide treatments have been tested and are required to attend continuing education classes on all general grounds maintenance, including tree and shrub care, to maintain their licenses.

DRIVEWAY TREATMENT

Due to either age or to the original construction method, many driveways

are eroding or sinking. The HG Board has discussed ways for homeowners to get reduced pricing for driveway replacement with asphalt or concrete, which is now priced competitively with asphalt.

A minimum number of addresses may be required to qualify for a group rate. The price will vary upon the driveway size and number of homeowners participating. If you are considering driveway replacement and have questions, would like more information or desire to have your name placed on a list of homeowners interested in obtaining a price quote, contact Jean Crotty at (651) 774-6464 before June 22.

Already this spring numerous homeowners have had their driveways sealcoated, while others are in need of care. Please be environmentally aware of the product that is placed on your driveway whether you do the job yourself or hire a contractor. Stay away from any sealcoating material that is a coal tar based emulsion.

MEDICATION RECYCLING

Washington County has installed a permanent drop-off box in the Law Enforcement Center Main Lobby at 15015 62nd Street North in Stillwater for residents to dispose of unused and expired prescriptions, free of charge.

Dumping medications in the trash or flushing them down the toilet are not

healthy options. Flushing them can pollute surface and groundwater and be harmful to fish and wildlife. Municipal sewage treatment plants are not equipped for proper disposal, and medications that end up in the trash at landfills can still end up in the groundwater.

The drop box is available from 7:30 a.m. to 5:00 p.m. Monday through Friday. Visit www.co.washington.mn.us/meds or call (651) 430-6655 for more details.

When dropping off medications:

- Leave them in their original containers.
- Black out personal information with a marker.
- If no longer in their original containers, write the name of the medication(s) on a clear plastic bag and place the medication in the bag.

The medications will be secured and taken to a waste-to-energy facility that is licensed to burn this type of waste.

You may have read that expired medications can be brought to pharmacies for disposal, but at this time none of our local pharmacies are accepting medications for disposal.

GENERAL RECYCLING

Washington County Environmental Center, located at 4039 Cottage Grove Drive in Woodbury, is open on the following days and times:

Tuesdays, Noon - 7:00 p.m. Thursdays, 9:00 a.m. - 2:00 p.m. Saturdays, 9:00 a.m. - 2:00 p.m.

The center accepts hazardous materials from home improvement, yard and garden, household items, automotive and recreation sources, household sharps and syringes, electronics and the usual paper, cans, bottles and plastics. SCOOP THE POOP

The January 2012 issue of the Woodbury City Update again reminds pet owners of their responsibility for cleaning up after their pets. Those who don't pick up the waste not only damage the landscape but also violate City Ordinances that require all pet owners to carry proper excrement removal supplies with them when walking pets off their property. By failing to do so you are at risk of being cited and fined.

Pet waste can lead to health issues. Parasites are easily transferable to other animals and to people, so picking up "poop" helps to prevent the spread of disease.

Dog feces have been observed in numerous areas of our Heritage Glen community, creating an unhealthy eyesore.

Section 7.2 of the Heritage Glen By-Laws addresses compliance with the City of Woodbury ordinance for domestic pets.

Section 7.13 states that occupants shall use the property in such a manner as will not cause a nuisance or impede the use of the property by other owners. It addresses not allowing any destructive or offensive activity on the property which may be or may become an annoyance or nuisance to any other owner or any other person lawfully residing on the property.

Section 7.15 states that no act shall be permitted which could cause an unusual liability, health or safety risk.

MINNESOTA TRIVIA
