### Noteworthy:

 The extreme fluctuations in weather this fall have made it a challenge for A-1 Maintenance to complete the fall clean-up of leaves. Just when the clean-up was scheduled, we got 7.9" of snow. Once that was melted and we enjoyed 75-degree weather again, A-1, like many other lawn maintenance contractors in the Twin Cities, had outfitted their trucks with snow plows and stowed away lawn care equipment. Mother Nature strikes again!

# WINTER PARKING AND PLOWING

Effective November 1, Woodbury's winter parking rules went into effect,

banning on-street parking between 2 a.m. and 6 a.m. through April 1, 2021.

The city ordinance also prohibits onstreet parking any time two or more inches of snow have accumulated, until after the street has been completely plowed - this applies to any hour of the day.

Residents who violate the ordinance will be ticketed. To avoid receiving a ticket, also please inform any guests you have about the restrictions so they don't receive a citation.

On recycling days, keep trash and recycling containers on your driveway, NOT ON THE STREET, so the plow won't hit them.

For new residents who haven't yet experienced Heritage Glen's winter guidelines and as a reminder for all of us:

- Driveways will be cleared after at least 1.5 inches of snow have accumulated.
- 2. Driveways will initially be opened up to allow access prior to 7:00 a.m. and 5:00 p.m. when continuous snow accumulation reaches 4 inches.
- 3. Driveways will be cleared within 8 hours of cessation for snow depths of 1.5 8 inches and within 12 hours of cessation for snow depths over 8 inches
- 4. A snowfall lasting 24 hours or more with an accumulation of at least 1.5 inches will be cleared to allow access.

- 5. Driveways that become closed by the city plows will be opened near the street.
- Sidewalk snow removal criteria are the same as for driveways, but sidewalks are generally cleared <u>after</u> the driveways have been completed.
- 7. A-1 Maintenance is not responsible for damage to any electrical cords which may be buried under snow on the sidewalks
- 8. Sidewalk snow removal will be delayed if wind chill temperatures reach 25 degrees below zero until safer conditions prevail.

Homeowners remain responsible for removal of snow AND ICE from:

- Sidewalks and driveways for accumulations of less than 1.5 inches
- Driveways due to parked cars
- Roofs, decks and patios
- Driveways or sidewalks caused by roof clearing
- Ice accumulation from water drainage on sidewalks, steps and driveways.

<u>Please do not run electrical cords across</u> <u>driveways or sidewalks</u>. Because vehicles parked in the driveway prohibit safe plowing and may incur damage, driveway plowing may be omitted.
